It involves also working closely with artists, educators, and community groups to create inclusive and impactful experiences that inspire a deep connection to contemporary dance. The Learning and Participation Manager will play a key role in broadening the company's reach and ensuring that our work is accessible to all.

# - Program Development and Delivery:

- Design and implement innovative learning and participation programs that engage diverse audiences, including workshops, masterclasses, school programs, and community projects.
- Collaborate with the Artistic Director and dancers to integrate learning opportunities into the company's artistic projects.
- Collaborate with FG fundraising consultant to develop specific funding bids to support the development of our engagement program.
- Develop tailored programs for different age groups, abilities, and community needs.

## - Community Engagement:

- Build and maintain relationships with schools, community organisations, and cultural institutions to foster collaboration and expand the company's reach.
- Identify opportunities for partnership to support and grow the learning and participation programs.
- Ensure the inclusion of underrepresented and marginalised communities in all programs.

- Oversee the management in collaboration with the Artistic Director of all learning and participation activities, including scheduling, budgeting, and resource allocation.
